the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

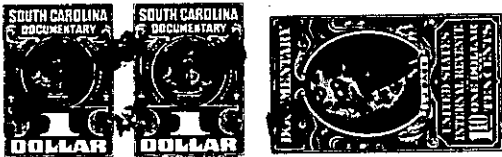
John Allan Jones and Almeda Maye Jones, their heirs and assigns forever:
