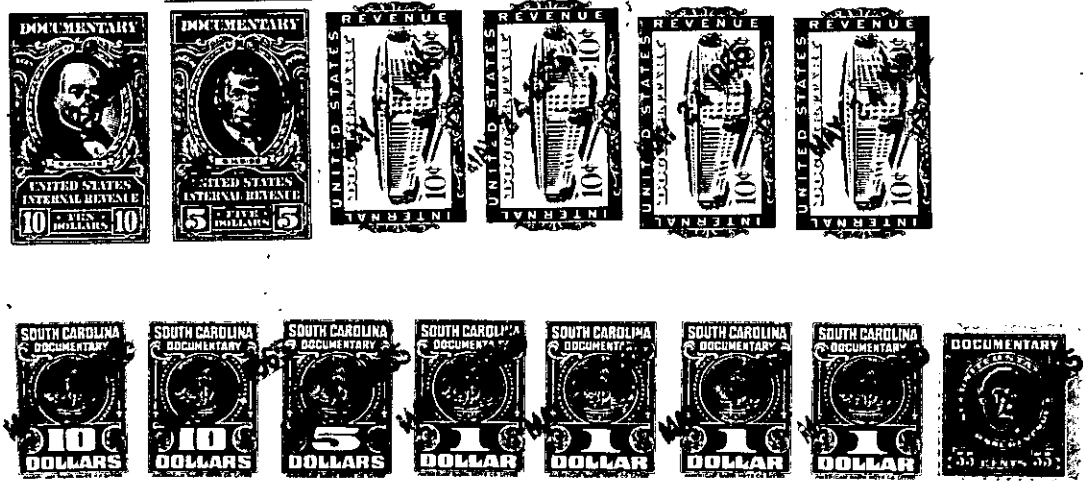
in consideration of Fourteen Thousand Five Hundred (\$14,500.00) and NO/100----- Dollars,
