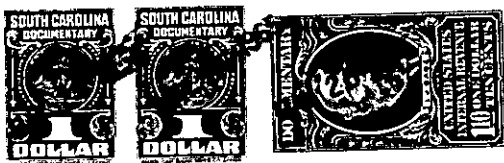
Mildred E. Penland, her heirs and assigns forever:
