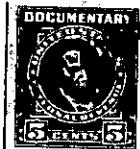

KNOW ALL MEN BY THESE PRESENTS, that I, J. Odell Shaver

in consideration of Sixteen Thousand, Four Hundred and 00/100 (\$16,400.00) Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Mozelle C. Watzl, her heirs and assigns forever:

ALL those certain pieces, parcels or lots of land in Austin Township, Greenville County, State of South Carolina, near the Town of Mauldin, and being known and designated as Lots Numbers 25 and 26 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R.M.C. Office for Greenville County in Plat Book BBB, at Page 15, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Northeastern side of Bartlett Street at the joint front corner of Lots 24 and 25, and running thence with the Northeastern side of Bartlett Street, N. 47-51 W. 100 feet to a point at the joint front corner of Lots 25 and 26; thence continuing with the Northeastern side of Bartlett Street, N. 47-51 W. 139.4 feet to a point; thence following the curvature of the Northeastern intersection of Bartlett Street with Fargo Street (the chord of which is N. 01-00 E. 32.9 feet) to a point; thence with the Southeastern side of Fargo Street, N. 49-50 E. 151.6 feet to a point at the rear corner of Lot 26; thence S. 47-51 E. 140.8 feet to a point at the joint rear corner of Lots 25 and 26; thence S. 47-51 E. 100 feet to a point at the joint rear corner of Lots 24 and 25; thence S. 42-09 W. 175 feet to a point on the Northeastern side of Bartlett Street at the joint front corner of Lots 24 and 25, the point of beginning.

This deed is executed subject to existing and recorded restrictions and rights-of-way.
