Know all men by these presents, That I, Hattie D. Perry of Honea Path, South Carolina, have constituted, made and appointed, and by these presents do constitute, make and appoint Hazel P. Mahony of Honea Path, South Carolina, my true and lawful attorney for me and in my name and stead, and to make use, to ask, demand, sue for, levy, recover and receive any and all sum or sums of money, debts, rents goods, wares, dues, accounts, and any other demands whatsoever, which are or shall be due, owing or payable to me or detained from me in any manner or ways or means whatsoever and to make all necessary banking and financial transactions in my behalf; and also

Giving and granting and conveying unto my said attorney, if in her discretion, it becomes necessary to sale, bargain or convey any or all land belonging to me in Anderson County/in order to support or maintain me during my lifetime. or Greenville County

Giving and granting unto Hazel P. Mahony, my said attorney, by these presents full and whole power, strength and authority, in and about the premises to have, use and take all lawful ways and means in my name for the recovery thereof or to convey or to sell any property or to do anything which may be necessary in taking care of me and in handling of my property in my best interest, welfare and support; and generally I give unto my said attorney all and every act, thing, devise, needful power or authority which may be necessary to do anything about the premises for me and in my name, to do, execute and perform, sale, convey and otherwise dispose of any or all property now belonging to me or hereafter coming into my possession as amply and fully and to all intents and purposes, as I might or could do if I were personally present, ratifying, allowing and holding, for firm and effectual purposes, all and whatsoever my said attorney shall lawfully do in and about the premises. My said attorney, in fact, is authorized to do as completely as I might do or could do any and all things if I were personally present.
