KNOW ALL MEN BY THESE PRESENTS, that I, Robert L. Alley,

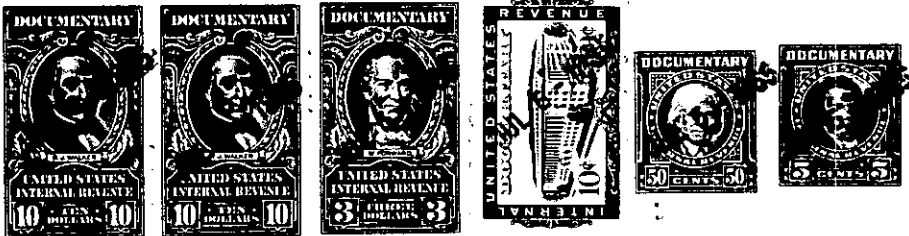
in consideration of Twenty-One Thousand Five Hundred and No/100 (\$21,500.00)----- Dollars,

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the western side of Waddell Road and being known and designated as Lot No. 40 of Wade Hampton Gardens as shown on plat thereof recorded in the R.
