

Hwy. No. 29), and being known and designated as Tract No. 3 and a portion of Tract No. 2 of Property of J. A. Simpson, as shown on plat thereof recorded in the R. M. C. Office for Greenville county, S. C., in Plat Book II, at Page 20, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of the Greenville-Piedmont Hwy. at the joint front corner of Tracts Nos. 3 and 4, and running thence along the line of Tract 4, N. 71-30 W. 470.3 feet, more or less, to a point in the center of the C & WC railroad; thence along the center of the said railroad as the line N. 5-34 E. 289.6 feet to a point; thence a new line through Tract No. 2, S. 71-30 E. 535 feet, more or less, to a point on the western side of Greenville-Piedmont Highway, which point is 35 feet N. 18-30 E. from the joint front corner of Tracts 2 and 3; thence along the said highway, S. 18-30 W. 35 feet to an iron pin at the joint front corner of Tracts 2 and 3; thence still with said highway, S. 18-30 W. 247.0 feet to the beginning corner.
