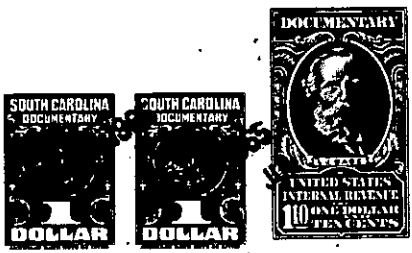
KNOW ALL MEN BY THESE PRESENTS, that LANCO, INC.

Mundy, Her Heirs and Assigns,

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 24, Pine Hill Village, as shown on a plat prepared by R. K. Campbell, R.L.S., dated November 30, 1960, recorded in the R.M.C. Office for Greenville County in Plat Book QQ at page 169 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwestern side of Kennedy Drive at the joint front corner of Lots Nos. 24 and 25 and running thence with the line of Lot No. 25 S. 29-22 W. 130 feet to an iron pin in the rear line of Lot No. 12; thence with the rear line of Lots Nos. 12 and 13 N. 60-38 W. 70 feet to an iron pin at the joint rear corner of Lots Nos. 23 and 24; thence with the line of Lot No. 23 N. 29-22 E. 130 feet to an iron pin on the Southwestern side of Kennedy Drive; thence with the Southwestern side of Kennedy Drive S. 60-38 E. 70 feet to the point of beginning.
