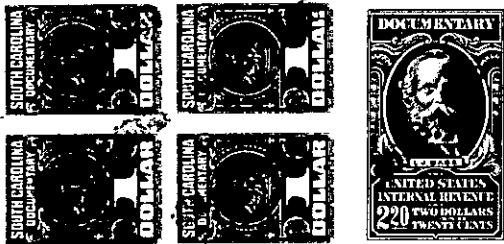
James H. Lindsey, his heirs and assigns forever:
