(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents

do grant, bargain, sell and release unto the said HELEN LUCINDA ROE TURNER, ROBERT BOLLING ROE, JR. and REBEKAH HULL ROE, Their Heirs and Assigns forever:
All that piece, parcel or tract of land in Highland Township, Greenville County, State of South Carolina, on waters of Mush Creek, containing 177½ acres, more or less, and bounded by lands, now or formerly owned by W. H. Perry, John Neves, Mrs. Pearson, Dr. T. E. Wood and others, being the place formerly known as the Dr. Miles Place, and being the homestead of L. H. Shumate at the time of his death. Being the same tract of land conveyed to Helen R. Thackston and Boyce Roe by Lucinda V. Neves by her deed bearing date of March 20th, 1929 and recorded in R. M. C.
