WILLIAM H. WHITE, HIS HEIRS AND ASSIGNS, FOREVER:

All that lot of land with the buildings and improvements thereon, situate on the North side of Miami Avenue, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 51 on Plat of Spring Brook Terrace, made by Woodward Engineering Company, March 15, 1958, recorded in the RMC Office for Greenville County, S. C., in Plat Book "KK", at Page 143, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the North side of Miami Avenue at joint front corner of Lots 50 and 51, and runs thence along the line of Lot 50, N. 2-0 W., 150 feet to an iron pin; thence S. 88-0 W., 75 feet to an iron pin; thence with the line of Lot 52, S. 2-0 E., 150 feet to an iron pin on the North side of Miami Avenue; thence along Miami Avenue, N. 88-0 E., 75 feet to the beginning corner.

As a part of the consideration the grantee assumes and agrees to pay the balance on that certain mortgage from Samuel Wayne Summers to Aiken Loan & Security Company, said mortgage being in the original amount of \$12,200.00, and was recorded on June 2, 1965, in Mortgage Book 996, at Page 431.

Grantor assigns and sets over to the grantee the insurance policy and escrow account in connection with the above loan.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs, or Successors and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
