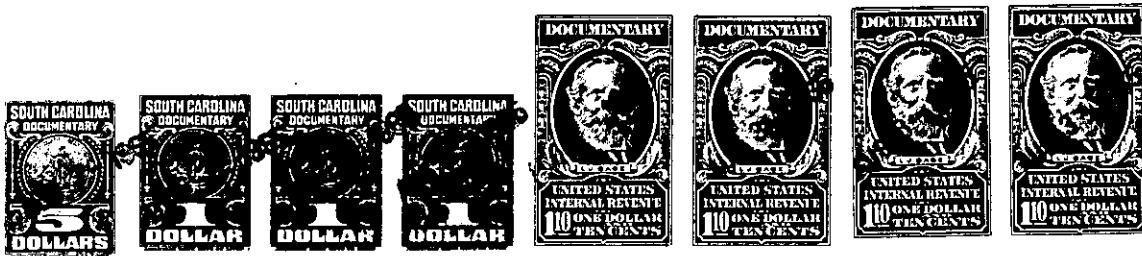
A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of * * * * * Three Thousand Nine Hundred Fifty and No/100 (\$3,950.00) * * * * * Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto R. Donald Bridges and Luneill F. Bridges, their heirs and assigns,

ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being the western one half of Lot 2 and the eastern one half of Lot 3 on plat of Drexel Terrace dated April 1, 1961 and prepared by Piedmont Engineering Service, recorded in the office of the R. M. C. for Greenville County in Plat Book QQ at page 177, and being more particularly described with reference to said plat as follows:

BEGINNING at a point on the northerly side of Dellrose Circle at a point S. 86-38 W. 50 feet from the joint corner of Lots 2 and 3, being the center of the front line of Lot 3, and running thence through the center of Lot 3 N. 3-22 W. 180 feet to a point in the center of the rear line of Lot 3; thence turning and running N. 86-38 E. 100 feet to a point in the center of the rear line of Lot 2; thence turning and running along the center of Lot 2 S. 3-22 E. 180 feet to a point on the northerly side of Dellrose Circle, being the center of the front line of Lot 2; thence turning and running along the northerly side of Dellrose Circle S. 86-38 W. 100 feet to the point of beginning.

Said lot is subject to protective covenants for Drexel Terrace recorded on April 7, 1961 in the office of the R. M. C. for Greenville County in Deed Book 671 at page 355 and to building set back line as shown on said plat.

This is a portion of the property conveyed to the Grantor herein by deed of W. B. Simmons, recorded on April 3, 1961 in the office of the R. M. C. for Greenville County in Deed Book 671 at Page 155.
