the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Frances Eleanor Wallace Brigham, her heirs and assigns:

All our right, title and interest, the same being an undivided two-thirds interest, of, in and to the following described property:

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, in the Second Ward of said City, and known as Lot No. 1 of Block 4 of Boyce Addition, according to a plat recorded in Plat Book "A" at Page 179 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeast corner of Pettigru and Toy Streets and running thence N. 15 W. 126 feet and 1 inch along Toy Street to an iron pin on a 10 foot alley; thence N. 76-45 E. 66 feet and 8 inches along said alley to an iron pin, corner lot No. 2; thence S. 15 E. 126 feet and 1 inch along line of Lot No. 2 to an iron pin on Pettigru Street; thence S. 76-45 W. 66 feet and 8 inches along said lot to the beginning corner.
