ALLISON AND LYNDA H. ALLISON:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 14 on plat entitled "Final Plat, Ogden Acres", prepared by Carolina Engineering & Surveying Co., dated September 25, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB at page 27, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southeastern side of Ogden Drive at the joint front corner of Lots Nos. 14 and 15, and running thence with the line of Lot No. 15 S. 33-40 E. 129 feet to an iron pin; thence N. 56-10 E. 120 feet to an iron pin at the joint rear corner of Lots Nos. 13 and 14; thence with the line of Lot No. 13 N. 33-40 W. 129 feet to an iron pin on the Southeastern side of Ogden Drive; thence with the Southeastern side of Ogden Drive S. 56-10 W. 120 feet to the point of beginning.
