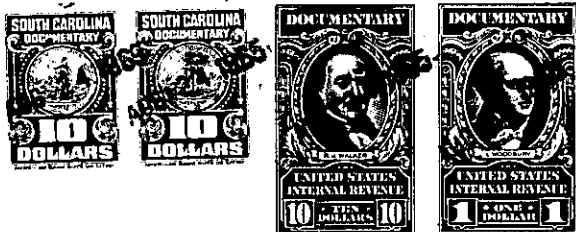
KNOW ALL MEN BY THESE PRESENTS, that I, Roy W. Bogges,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Dorothy Louise Allen, her Heirs and Assigns forever:

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the northern side of Mayo Drive and being known and designated as Lot No. 96 of Paramount Park and shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "W", at Page 57, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Mayo Drive at the joint front corner of Lots Nos. 96 and 97 and running thence along the northern side of said Drive, S. 65-00 W. 70 feet to an iron pin; thence along the joint line of Lots Nos 95 and 96 N. 26-00 W. 187.8 feet to an iron pin; thence N. 57-34 E. 70.3 feet to an iron pin; thence along the joint line of Lots Nos. 96 and 97 S. 26-00 E. 195.7 feet to the point of beginning.
