All that certain piece, parcel or lot of land lying and being on the southwesterly side of Theodore Drive near the City of Greenville, S. C., being known and designated as Lot No. 22 on plat of Carolina Heights as recorded in the RMC Office for Greenville County, S. C. in Plat Book BBB, page 29, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Theodore Drive, said pin being the joint front corner of Lots 22 and 23, and running thence with the southwesterly side of Theodore Drive N 48-22 W 80 feet to an iron pin; thence on a curve, the chord of which is S 86-38 W, 35.3 feet to an iron pin on the southeasterly side of a 50 foot street; thence with the southeasterly side of said 50 foot street S 41-38 W 120 feet to an iron pin; thence S 40-22 E 105 feet to an iron pin at the joint rear corner of Lots 22 and 23; thence with the common line of said lots N 41-38 E 145 feet to an iron pin on the southwesterly side of Theodore Drive, the point of beginning.
