Immediately upon the completion of the merger, Piedmont shall be considered and is hereby declared to be completely merged into Southern within the meaning and intent of Section 12-20.1, et seq., of the Code of Laws of South Carolina, 1962, as amended.

10.

The by-laws of Southern, except as may be necessarily modified by this agreement, are hereby adopted as the by-laws of the surviving corporation, until otherwise changed, and the Directors and Officers of Southern shall be the Directors and Officers of the surviving corporation, until otherwise changed.
