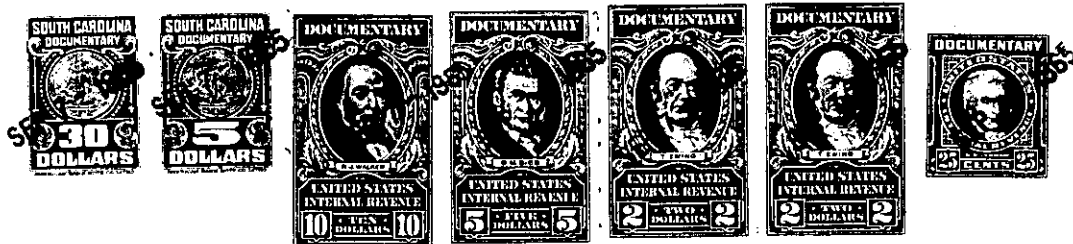
KNOW ALL MEN BY THESE PRESENTS, that Verlie W. Campbell and Beulah S. Campbell
