in consideration of Eight Thousand, Five Hundred and no/100 (\$8,500.00) and assumption of mortgage hereinafter mentioned are receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release to June L. Dean, her heirs and assigns forever:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lots Nos. 19 and 30 and a strip 10 feet in width from the southerly side of Lots Nos. 20 and 29 according to a map of Franklin Park Subdivision, property of D. Frank Williams, prepared by W. J. Riddle, Surveyor, December, 1943 and recorded in the R. M. C.
