CHURCH AND VO GENERAL ASS EMBLY OR GROUP OF PEOPLE IN ANY STATE SHALL NOT CHANGE THIS OF THE GENERAL OVERSEER BY VIRTUE OF THE AUTHORITY THAT (... GIVES ME AND ANY STATEOVERSEER IS PASTORING A CHURCH AND THE CHURCH IS NOT SATISFIED WITH HIM, THE CHURCH CAN CALL A MESTING AMONG THEMSELVES AND SUGGEST THE MATTER OVERAND IF IT IS THEIR DESIRE TO CHANGE THE STATEOVER-TISEER FROM BEING THEIR PASTOR AND IF THEY FEEL LIKE THEIR STATEOVERSEER WON'T RESIGN AND GIVE THEM ANOTHER PASTOR, THEN THEY SHALL CALL THE GENERAL O'VERSEER FOR A BUSINESS MEETING THEN IF THE STATE OVERSEER WON'T RESIGN, THEN THEN HE SHALL BE BROUGHT INTO ACHARGE AND HIS STATE AND HIS POSITION OF HIS STATE SHALL BE TAKEN AWAYFROM HIM, IF THE CHURCH HAS ANY RIGHT OF 'ALL' IN

CHANGING PASTORS. AND IF THE GEMERAL OVERSEER CAN PASTOR ANY WORK AND WAMIS TO: PASTOR AND HAS TIME TO PASTOR ANY CHURCH HE CAN PASTOR ANY GROUP OF PEOPLE AT ANY LOCAL CHURCH OR THE CHURCH AT HEADQUARTERS AS HE LIKES UNTILL ALL MATTERS IS SETTLED. THEN IF ANY GROUP WANT HIM AS PASTOR HE CAN PASTOR FOR THEM AS HE LIKES AND IF THE GENERAL OVERSEER SEE IT BEST TO GET ANOTHER MINISTER TO TAKE THE PASTOR WORK, THEN HE CAN DO SO WITHOUT ANY OBJECTIONS. THE GENERAL OVERSEER AND THE STATE OVERSEER SHALL AGREE UPON THIS FOR PAST OF FOR THE CHURCH. AND THIS QUORUM HAVE, AND SHALL HAVE POWER TO RECEIVE

PROPERTY BY PURCHASE, GIFT, DEVISE OR BEQUEST TO SELL THE SAME AND APPLY THE PROCEEDS TOWARD THE PROMOTION OF THE OBJECTS FOR WHICH IT IS CREATED OR HOLD ANY SUCH PROPERTY AND APPLY THE INCOME AND PROFIT TOWARD SUCH COBJECTS. THE GENERAL OWELFARE OF THE SOCIETY ARE NOT INDIVIDUAL PROFIT AND

THE MEMBERS ARE NOT STOCKHOLDERS IN THE LEGAL SENSE OF THE TERM AND NO DIVIDENDS OR PROFITS SHALL BE DIVIDED AMONG THE MEMBERS, THE GENERAL ...

POWER OF THE SAID QUOUM.ITS MINISTERS MAY ESTABLISH CHURCHES IN ANY STATE OR COUNTRY. THE BOARD OF DIRECTORS SHALL KEEP A RECORD OF ALL THEIR PROCEEDINGS WHICH SHALL BE AT ALL TIMES SUBJECT TO THE INSPECTION OF THE GENERAL POWER OF THE SAID QUORUM. ITS MINISTERS MAY ESTABLISH CHURCHES IN ANY STATE OR COUNTRY, THE BOARD OF DIRECTORS SHALL KEEP A RECORD OF ALL THEIR PROCEEDING WHICH SHALL BE AT ALL TIMES SUBJECT TO THE INSPECTION OF THE GENERAL OVER SEER OR OF ANY MEMBER AND ITS MINSTERS AND MEMBERS CANNOT WAVE

ITS PROPERTY INTO ANY OTHER QUORUM OR CHART AT ANY TIME TO APPOINT SUCH SUBORDINATE OFFICER AND AGENTS IN ADDITION TO THE GENERAL OVERSEER AND SECRETARY OR TREASURER IN THE BUSINESS OF THE QUROUM MAY REQUIRE TO DESIGNATE THE NAME OF THE COFFICE AND FIX THE COMPENSATION OF THE OFFICER TO SORROW MONEY TO BE USED IN PAYMENT OF PROPERTY BOUGHT BY IT. AND FOR ERECTING BUILDINGS MAKING IMPROVEMENTS AND FOR OTHER PURPOSES GERMANE TO THE OBJECTS ITS CREATION AND SECURE THE REPAYMENT OF THE MONEY THUS BOR REWED BY MORTGAGE, PLEDGEOR DEED OF TRUST UPON SUCH PROPERTY AS MAY BE OWNED BY IT AND IT MAY IN LIKE MANNER SECARE BY MORTGAGE, PLEDGE OF DEED OF TRUST ANY EXISTING INDEBTEDINESS WHICH IT MAY HAVE LAWFULLY COMPRACTED.
