I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Polly P. Crisp and P. D. Forrest, Jr.

on or about the _____ day of July _____ in the year of
 our Lord nineteen hundred and Sixty Five _____ exhibited their
 complaint in the Court of Common Pleas _____ for the County aforesaid, against

_____ demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard
 on the 24th _____ day of September _____ 1965,
 and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and
 decreed that the said real estate hereinafter mentioned and described, be conveyed by E. INMAN, Master in and for
 the County aforesaid, to P. D. Forrest, Jr.

_____ for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;
 (See Judgment Roll No. J-5175...)

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County of
 Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto
 the said P. D. Forrest, Jr., all the right, title and interest of Barbara
 Jane Forrest and Daniel Bedford Forrest in and to the following described
 real estate:

Tract No. 4.

"ALL that certain piece, parcel or tract of land, situate, lying and
 being in the County of Greenville, State of South Carolina, containing
 5.26 acres, more or less, and having the following metes and bounds,
 according to a plat thereof made by J. C. Hill, under date of August 7,
 1965, recorded in Plat Book KKK, page 141, to wit:

"BEGINNING at a point in the center of Geer Highway #276, at corner of
 property being conveyed to Polly P. Crisp, and running thence along the
 center of said Highway: S. 88-00 E. 100 feet; thence S. 85-20 E. 100
 feet; S. 77-10 E. 100 feet; S. 69-15 E. 100 feet; S. 61-10 E. 100 feet;
 S. 54-50 E. 100 feet; S. 53-30 E. 255.8 feet; thence leaving said High-
 way, S. 5-11 E. 180.3 feet to a point; thence N. 71-00 W. 150 feet to a
 point; thence N. 77-00 W. 617.1 feet to an iron pin; thence N. 7-30 W.
 332 feet, more or less, to the beginning corner."

This deed is made pursuant to the Order of the Court and is for the
 partition of land by and between the plaintiffs and defendants and is
 without any monetary consideration and for that reason it is not
 necessary to place any revenue stamps on the Master's deed.
