

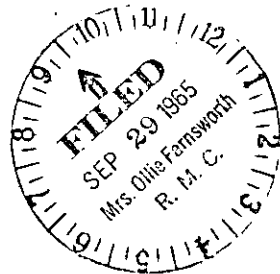

in consideration of One Thousand Three Hundred Fifty and no/100 (\$1,350.00) -- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Willie Green, His Heirs and Assigns, Forever:

ALL that piece, parcel or lots of land located in the County of Greenville, State of South Carolina, situate, lying and being on the southeastern side of Boling Circle and being known and designated as Lots Nos. 23, 24, 25 and 26 on plat of property of William Goldsmith, Jr. and J. Morgan Goldsmith, dated May 20, 1960 by J. Mac Richardson and has, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the southeastern side of Boling Circle, joint front corner of Lots Nos. 22 and 23, and running thence N. 41-54 E. 50 feet to a point; thence continuing along said Boling Circle N. 38-10 E. 50 feet to a point; thence running along the joint line of Lots Nos. 26 and 27, S. 51-50 E. 100 feet to a point; thence running S. 38-10 W. 50 feet to an old iron pin in root of 48 inch oak; thence running S. 38-10 W. 64.5 feet to a point; thence running N. 44-08 W. 104.9 feet to the point of beginning.
