release unto Wesley D. Mayfield and Ann G. Mayfield

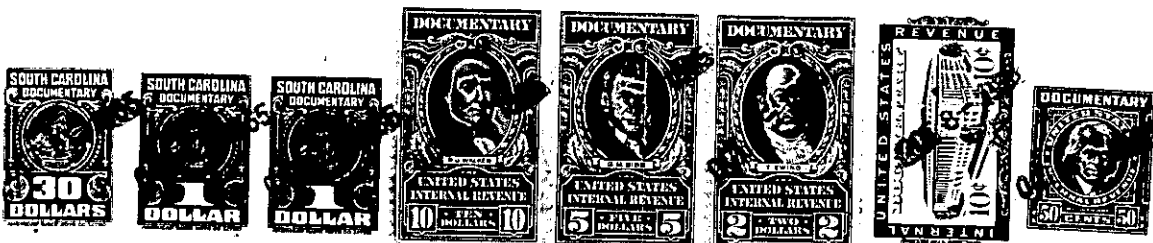
