in consideration of Twelve Thousand and No/100 (\$12,000.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Hubert C. Dobson, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina being known and designated as Lot No. 2, Block F, Section 3 on plat of East Highlands Estates plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "K", Page 36 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Carolina Avenue, joint front corner of Lots Nos. 1 and 2, said pin being 87.5 feet south of the intersection of Carolina Avenue and Wait Street and running thence with the common line of said lots N. 66-30 E. 175 feet to an iron pin; thence with the rear line of Lot No. 2 S. 32-00 E. 80 feet to an iron pin, joint rear corner of Lots Nos. 2 and 3; thence with the common line of said lots S. 67-17 W. 175 feet to an iron pin on the northeastern side of Carolina Avenue; thence with said Avenue N. 32-15 W. 78 feet to an iron pin, the point of beginning.
