In consideration of SEVEN HUNDRED FIFTY AND NO/100-----(\$750.00)----- Dollars,

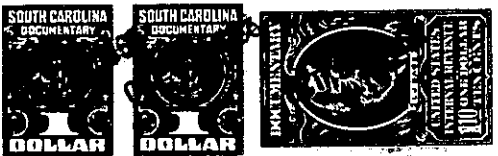

ALL that certain piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, within the corporate limits of the City of Greenville and being known and designated as Lot Number 20 of a subdivision known as Essex Court, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book W at Page 31, and having the following metes and bounds, to wit:

BEGINNING at a point on the Eastern side of Essex Court at the joint front corner of Lots 20 and 21 and running thence with the Eastern side of Essex Court following the curvature of the turnaround approximately N 07-28 E 70 feet to a point at the joint front corner of Lots 20 and 19 (now Lot 38); thence N 63-30 E 85.5 feet to a point at the joint rear corner of Lots 20 and 19 (now Lot 38); thence S 01-50 E 100 feet to a point at the joint rear corner of Lots 20 and 21; thence S 85-03 W 89.2 feet to a point on the Eastern side of Essex Court, the point of BEGINNING.
