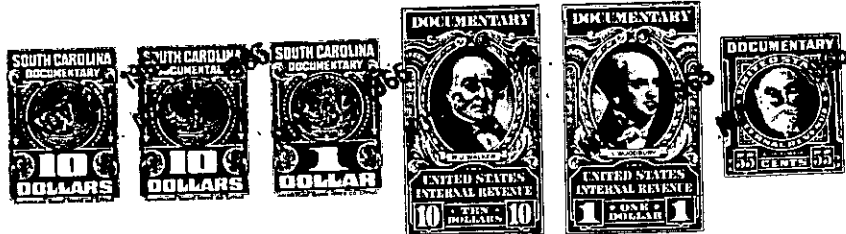
KNOW ALL MEN BY THESE PRESENTS, that

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Larry G. Mote, his heirs and assigns,

ALL that piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the norther side of Converse Street (formerly known as Circle Street), in an area recently annexed into the City of Greenville, County of Greenville, State of South Carolina, being known as Lot No. 9 on plat of Tract No. 3, Overbrook subdivision, known as Hillside Heights, made by R. E. Dalton, Engineers, September 1921, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book F, page 100; said lot being triangular in shape and having according to said plat the following metes and bounds, to-wit;

BEGINNING at an iron pin on the northern side of Converse Street at the joint front corner of Lots Nos. 8 and 9, and running thence with the line of Lot No. 8, N 3 03 E 207.7 feet to an iron pin; thence along the line of Lot No. 10, S 38 50 W 214.5 feet to an iron pin on the northern side of Converse Street; thence with the northern side of Converse Street following the curve thereof (the chord of which being S 57 51 E 60 feet) to an iron pin; thence continuing with the curve of Converse Street (the chord of which being S 83 02 E 72.6 feet) to the BEGINNING corner.
