All that certain piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the Western side of Davis Street, on the Northern side of E. Court Street, on the Southern Side of E. McBee Avenue and having, according to a plat entitled "Property of Greenville Auto Sales, Inc.", dated July 29, 1965, prepared by Carolina Engineering & Surveying Co., recorded in the R.M.C. BEGINNING at a nail in the pavement at the Northwestern corner of the junction of Davis Street with E. Court Street and running thence N. 64-00 W. 203.5 feet to an iron pin in the pavement of E. Court Street; thence N. 24-40 E. 77.5 feet to an iron pin; thence S. 67-10 E. 48.3 feet to an old iron pin; thence N. 23-40 E. 87.0 feet to an old iron pin; thence N. 22-50 E. 134.8 feet to a point on the Southern side of E. McBee Avenue; thence with the Southern side of E. McBee Avenue S. 69-20 E. 12.0 feet to an old iron pin; thence S. 23-05 W. 73.2 feet to an old iron pin; thence S. 62-45 E. 70.7 feet to a point; thence S. 64-47 E. 70.3 feet to a point on the Western side of Davis Street; thence with the Western side of Davis Street S. 23-05 W. 173.2 feet to an old iron pin; thence continuing S. 23-05 W. 56.2 feet to the point of beginning. Exception is taken for encroachments of E. Court Street as shown of the above plat. Also, exception is taken for any driveways or alleys as may exist on the property.
