KNOW ALL MEN BY THESE PRESENTS, that We, T. Frank Huguenin, John T. Douglas and Nora Camille McDaniel Manning

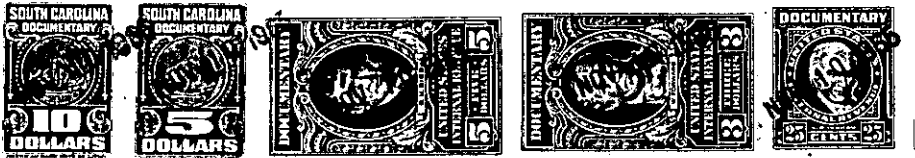
in consideration of SEVEN THOUSAND FIVE HUNDRED AND NO/100----- Dollars,

All that lot of land, situate on Rockingham Road in Greenville County, State of South Carolina, being shown as Lot No. 17 Rockingham Road, on plat of Barksdale subdivision made by Dalton & Neves, Engineers, December 1959, recorded in the R. M. C. Office for Greenville County S. C. in Plat Book "QQ" Pages 118-119 and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the South Side of Rockingham Road, joint front corner of Lots 16 and 17 and running along the line of Lot 16 S. 34-03 E. 280 feet to an iron pin, joint rear corner of Lots 16, 17, 40 and 41; thence along the rear line of Lot 40 S. 55-57 W. 145 feet to an iron pin; thence along the line of Lot 18 N. 35-04 W. 280 feet to an iron pin on Rockingham Road, joint front corner of Lots 17 and 18; thence along Rockingham Road N. 55-57 E. 150 feet to an iron pin, the beginning corner.
