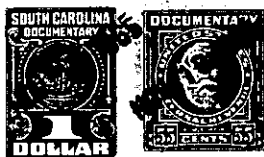

KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

in consideration of - - Three Hundred Ninety-five and No/100 (\$395.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Norman J. Hudson and Floy W. Hudson, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot No. 9 of a subdivision known as Elizabeth Heights, as shown by a plat thereof, dated May 1, 1956 by Madison H. Woodward, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 11, and having according to said plat the following description, to-wit:

Beginning on Satterfield Drive at an iron pin at joint front corners of Lots 8 and 9 and running thence 75 feet with the line of said Drive to an iron pin at joint front corners of lots 9 and 10; running thence 150 feet with the side line of lot 10 to an iron pin at joint rear corners of lots 9 and 10 and Harvey property; running thence 75 feet with the line of Harvey property and the rear line of lot 9 to an iron pin at joint rear corners of lots 8 and 9 and Harvey property; running thence 150 feet with the side line of lot 8 to the iron pin on Satterfield Drive at joint front corners of lots 8 and 9, the point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lots; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty (30) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business shall be erected on any lot other than lots fronting on Stauton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay taxes for the year 1965.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)'s heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)'s heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)'s heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
