the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William H. Burgin, his heirs and assigns forever:

ALL that lot of land in the State of South Carolina, County of Greenville, in Chick Springs Township, being a portion of Lot No. 88 in Pinebrook Development, plat of which is recorded in Plat Book Z, at page 148, and having the following metes and bounds, to-wit:

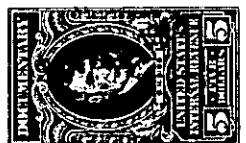
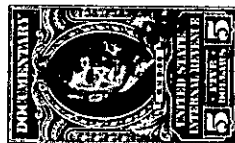

BEGINNING at an iron pin at the Southeastern corner of said lot and running thence N. 27-49 W. 106 feet to an iron pin on the edge of a Duke Power right-of-way; thence along the edge of said right-of-way, S. 73-06 W. 145 feet to the joint rear corner with the lot described above; thence S. 33-31 E. 159.4 feet to an iron pin on the northern edge of Bridges Avenue; thence with the edge of said Avenue, N. 51-06 E. 122.5 feet to the point of beginning.
