release unto Willie Harkins and Anne M. Harkins, their heirs and assigns forever:

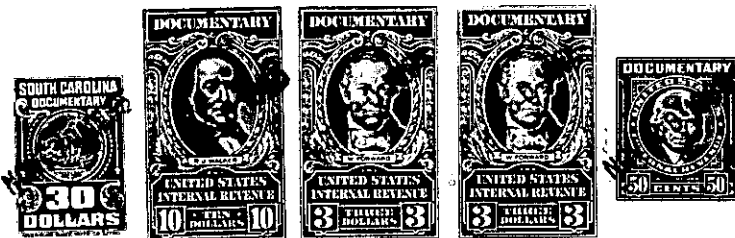
