All those certain pieces, parcels, or lots of land in the County of Greenville, State of South Carolina, on the northerly side of S. C. Highway No. 253 and being at the northeasterly intersection of said Highway and Fontana Drive, and being shown as Lots Nos. 4 and 5 on plat of Fontana Forest, recorded in the RMC Office for Greenville County, S. C., in Plat Book "YY", at Page 171, and having according to said plat the following metes and bounds, when described together, to wit:

BEGINNING at an iron pin on the northerly side of S. C.
