in consideration of Ten Dollars and Assumption of Mortgage (\$10.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto George Peterson, his heirs and assigns forever

ALL that lot of land in the County of Greenville, State of South Carolina, in Bates Township, known as Lot 6 on plat of property of Montevideo, Section 2, recorded in Plat Book "MM" at page 125, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Echo Lane at the corner of Lot 5 and running thence with said lot N. 68-27 W., 168 feet to an iron pin; thence S. 20-37 W., 100 feet to an iron pin at the corner of Lot 7; thence S. 68-30 E. 167.1 feet to an iron pin on the northwestern side of Echo Lane; thence N. 21-08 E., 100 feet to the point of beginning and being the same property conveyed to me in Deed Book 745 at Page 428.

This property is subject to the restrictive covenants of record pertaining to Montevideo in Deed Book 599 at page 75, with the following amendments: That in paragraph 5 thereof, the lot shall be not less than 75 feet wide at the front building set back line and, in paragraph 7 thereof, the building set back line shall be 50 feet; otherwise, the remaining covenants shall apply.

The Grantees assume and agree to pay that certain mortgage heretofore given to the Travelers Rest Federal Savings and Loan Association in the present amount of \$9,034.81, recorded in the R. M. C. Office for Greenville County in Mortgage Book 860 at Page 385.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee(s)' heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
