KNOW ALL MEN BY THESE PRESENTS, that We, Florrie E. Greer and William J. Greer

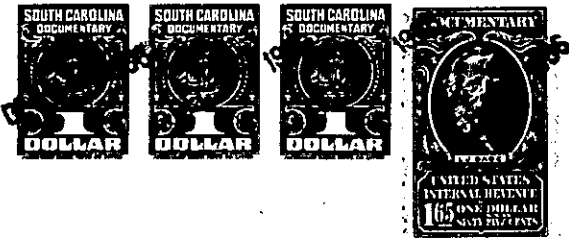
in consideration of One thousand Two Hundred seventy-five and no/100 - - - - - Dollars,
