in consideration of Seventy-Three Hundred Fifty and No/100 (\$7350.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edward H. Hembree, his heirs and assigns,

All that piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot No. 112 on plat of Property of the Estate of Tully P. Babb, recorded in Plat Book QQ at Pages 162-163, in the R. M. C. Office for Greenville County, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the northern side of Cleveland Street Extension, at the joint front corner of Lots 111 and 112, and running thence with line of Lot 111, N. 19-39 E. 309.8 feet to iron pin in line of Lot 110; thence with line of Lot 110, S. 75-19 E. 155 feet to iron pin on Stonehaven Drive; thence with said Stonehaven Drive S. 17-41 W. 363 feet to iron pin on the curve of the intersection of Stonehaven Drive and Cleveland Street Extension; thence with the curve of the intersection of Stonehaven Drive and Cleveland Street Extension, the chord of which is S. 77-27 W. 40.4 feet to iron pin; thence with Cleveland Street Extension N. 42-48 W. 92.1 feet to iron pin; thence continuing with said Cleveland Street Extension N. 50-15 W. 54.3 feet to the beginning corner.

This deed is made pursuant to authority granted to Emma L. Flinkingshelt, as Trustee, in deed recorded in Deed Book 485 at Page 410, and by authority granted to the grantor as will be seen in the will of the late Elizabeth H. Babb, who died testate on November 3, 1962 (see Apt. 807, File 16 in the office of the Probate Court for Greenville County).

This property is conveyed subject to the following restrictions:

1. The property shall be used for single unit residential dwellings only.
2. No house shall be constructed on said lot containing less than 2200 square feet, exclusive of porches, carports and breezeways. (3) Lots 111 and 112 may be recur to face Stonehaven Drive so long as only one residential dwelling is placed on each lot with a minimum frontage of 150 ft. facing on Stonehaven Drive.

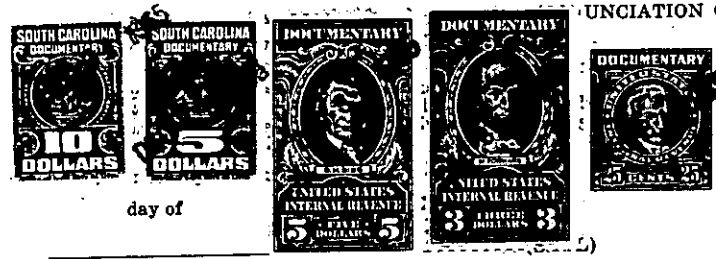
