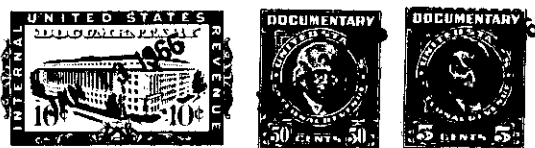
KNOW ALL MEN BY THESE PRESENTS That ^{C.L.} QUINN CONSTRUCTION CO.
