to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto WILLIAM A. HAMMOND:

ALL that piece, parcel or lot of land situate, lying and being on the North-eastern side of Floyd Street in the County of Greenville, State of South Carolina, and known and designated as Lot 2 as shown on a plat entitled "Property of J. P. Stevens & Co., Inc." made by Piedmont Engineers and Architects November 9, 1965, and recorded in the R.M.C. Office for Greenville County in Plat Book LLL at page 65, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Floyd Street at the joint front corner of Lots 2 and 3 and running thence with the Northeastern side of Floyd Street N. 51-33 W. 70 feet to an iron pin at the joint front corner of Lots 1 and 2; thence with the common line of said two lots N. 38-27 E. 110 feet to an iron pin in the Southerly line of Lot 7; thence with the line of Lot 7 S. 51-33 E. 70 feet to an iron pin at the joint rear corner of Lots 2 and 3; thence with the common line of said two lots S. 38-27 W. 110 feet to an iron pin on the Northeastern side of Floyd Street, the point of beginning.

In accepting this conveyance, the grantee agrees for himself, his heirs and assigns that the above described property shall be used for residential purposes only.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, his heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
