the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

JOHNNY H. MAHAFFEY and DORRIE MAHAFFEY, their heirs and assigns,

ALL that piece, parcel or lot of land with improvements lying on the northern side of Blossom Drive in Gantt Township, Greenville County, South Carolina, being shown as Lot No. 9 on a Plat of Kennedy Park, made by Piedmont Engineers & Architects, dated September 28, 1964, as revised, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book JJJ, Page 44, and having according to said Plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Blossom Drive at the joint front corners of Lots Nos. 9 and 10 and running thence N. 2-42 E. 130.6 feet to an iron pin; thence N. 87-37 W. 75.1 feet to an iron pin; thence along the common line of Lots Nos. 8 and 9 S. 2-42 W. 130.2 feet to an iron pin on Blossom Drive; thence along the northern side of Blossom Drive S. 87-18 E. 75 feet to an iron pin, the beginning corner.

The above described property is hereby conveyed subject to easements and building restrictions of public record and to the building setback line shown on the recorded Plat.

As a part of the consideration for this Deed, the Grantees assume and agree to pay in full the indebtedness covering the above described property on a note and mortgage in favor of Fountain Inn Federal Savings & Loan Association, recorded in the R.M.C. Office for Greenville County, South Carolina, in Mortgage Book 1016, Page 279, which has a present balance due in the sum of \$8,650.00.
