ALL that certain piece, parcel or lot of land located in Cleveland Township, Greenville County, State of South Carolina, designated as Lot No. 2 of the Oliver W. Hardin property, and having the following courses and distances, to-wit:

BEGINNING at the joint corner with Lot No. 1 on Table Rock Dam Road, and running thence 80 feet with said Road; thence in a straight line from said Road to the center of Saluda River; thence along said River 80 feet to a point on Lot No. 1; thence with the line of Lot No. 1 to the point of beginning.
