KNOW ALL MEN BY THESE PRESENTS, that I, Russell W. Robertson,

in consideration of Ten Dollars and other considerations Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Homer E. Young

All that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, on the North side and adjoining South Saluda River. Same being a portion of a tract of land of the W. B. Hardin Estate, deceased and having the following metes and bounds, to-wit:

BEGINNING at the Mouth Hog Branch on South Saluda River; thence up said Branch following the meanders thereof 9.50 from center of River to Stone X 0 on West side of Branch near top of shoal; thence N. 85-3/4 W. 6.09 to stone X 0 W 0 down; thence S. 83 W. 3.27 to stone X 0; thence N. 48 W 2.20 to center of Clibone Mill Creek, near top of Shoal; thence down said creek following the meanders thereof 11.00 chains to center of South Saluda River; thence down the River with meanders thereof 5.00 chains to Mouth of Hog Branch to the beginning, containing seven (7) acres, more or less, adjoining lands of Alvin W. Hardin, V. T. Hardin McGee on the East Ab. Mc Junkins and others.
