All of that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, and within the corporate limits of the City of Greenville, being known and designated as the rear portion of Lot No. 52 and the rear portion of Lot No. 57 of a subdivision of the property of the Overbrook Land Company according to a plat thereof prepared by H. Olin Jones, September 17, 1913, which plat is of record in the R. M. C. Office for Greenville County in Plat Book E at page 252, and also being known and designated as Lot No. 2 on a plat entitled "A revision of Lots 56 and 57, Overbrook Road" prepared by Woodward Engineering Company, June, 1953, and having, according to the last mentioned plat, the following metes and bounds. to-wit: and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Balsam Road, the joint front cormer of Lots Nos. 1 and 2 as shown on the Woodward plat above mentioned, said pin being 10 feet westerly from the joint rear corners of Lots Nos. 51 and 52 as shown on the Jones plat above mentioned, and running thence along the joint line of Lots 1 and 2 as shown on Woodward plat, N. 4-03 W. 134.9 feet to an iron pin; thence N. 88-30 E. 12.3 feet to an iron pin (this corner being located on the joint line of Lots Nos. 51 and 52 as shown on the Jones plat above mentioned); thence N. 76-07 E. 80 feet to an iron pin; thence S. 7-41 E. 59.7 feet to an iron pin, the joint rear corner of Lots Nos. 56 and 57 as shown on both said plats above mentioned; thence S.0-26 E. 92 feet to an iron pin on the northern side of Balsam Road; thence along the northern side of Balsam Road, following the curvature thereof, the chord of which is is N. 83-13 W. 57.5 feet to an iron pin; thence continuing along the northern side of Balsam Road, following the curvature thereof, the chord of which is approximately N. 83 W. 12.5 feet to an iron pin; thence continuing along the northern side of Balsam Road, following the curvature thereof, the chord of which is N. 83-41 W. 10 feet to the beginning corner.
