in the State aforesaid, in consideration of the sum of division of real estate and One and No/100ths (\$1.00)----- Dollars,

to us in hand paid at and before the sealing of these presents by A. B. McJUNKIN, JR.

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said A. B. McJUNKIN, JR., his heirs and assigns:

ALL that certain piece, parcel or tract of land, situate, lying and being in the County of Greenville, State of South Carolina, containing 19.67 acres, more or less, and being shown on plat entitled "Property of Abner McJunkin Est.," dated November 23, 1965, prepared by J. C. Hill, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book \_\_\_\_\_, page \_\_\_\_\_, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin in the line of property now or formerly known as Fortner property and running thence with the line of said Fortner property N. 71-50 E. 1,104 feet, more or less, to an iron pin; thence S. 15 E. 1,483 feet to a stone; thence N. 88-30 W. 100 feet to an old stone; thence N. 50-45 W. 1,688 feet to the point of beginning.
