the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto William H. Harrison, one-third undivided interest, William O. Harrison, two-ninths undivided interest; George B. Harrison, two-ninths undivided interest and Marvin H. Harrison, two-ninths undivided interest, theirheirs and assigns forever,

All that lot of land located inthe City of Greenville, Greenville County, South Carolina, in the subdivision known as Sherwood Forest, being shown on plat of Sherwood Forest, made by Dalton & Neves, Engineers, August 1951, revised through June 1953, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "GG", Pages 70 and 71, said lot being known as Lot No. 173 corner of Lady Marián Lane and Robinhood Road, being more particularly described as follows:

BEGINNING at an iron pin on the south side of Lady Marian Lane, joint front corner of Lots 172 and 173 and running along the line of Lot 172 S. 16-10 W. 196.9 feet to an iron pin on line of Lot 174; thence along the line of Lot 174 N. 59-08 W. 106.6 feet to an iron pin on Robinhood Road; thence along Robinhood Road N. 27-18 E. 95 feet to an iron pin; thence continuing with Robinhood Road N. 19-22 E. 90 feet to an iron pin; thence along the curve of Robinhood Road and Lady Marian Lane S. 79-21 E. 40.9 feet to an iron pin, thence along Lady Marian Lane S. 49-54 E. 42.4 feet to an iron pin, the beginning corner.
