All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the southwestern side of Hampton Avenue and being known and designated as Lot No. 3 on plat of Property of T. C. Gower Lots, recorded in the R. M. C. Office for Greenville County in Plat Book "C", at Page 43 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Hampton Avenue at the joint front corner of Lots Nos. 1 and 2 and running thence along said Avenue N. 32-25 W. 51 feet to an iron pin; thence along the joint line of Lots Nos. 3 and 4 S. 57-35 W. 140 feet to an iron pin; thence along a 10-foot alley S. 32-25 E. 51 feet to an iron pin; thence along the joint line of Lots Nos. 2 and 3 N. 57-35 140 feet to the point of beginning.
