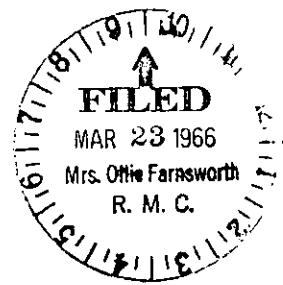

Darvin F. Earle and Clara M. Earle, their heirs and assigns, forever:

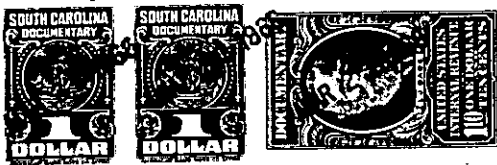
