KNOW ALL MEN BY THESE PRESENTS, that I, R. C. Ayers,

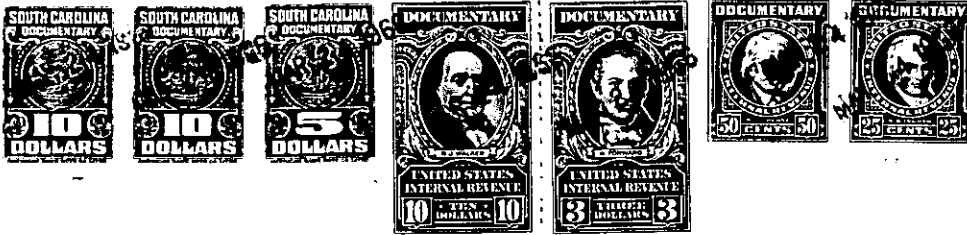
in consideration of Twelve Thousand Three Hundred and No/100 (\$12,300.00)-----Dollars,
