the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

J. B. Silvey and Melba Silvey, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 10 as shown on a Plat of Valencia Estates by W. N. Willis, Engineers, dated November 19, 1960, recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 179, and having according to said Plat, the following description, to-wit:

BEGINNING on Valencia Drive at an iron pin at joint front corners of Lots 9 and 10 and running thence 80 feet with the line of said Drive to an iron pin at joint front corners of lots 10 and 11; running thence 180 feet with the side line of lot 11 to an iron pin at joint rear corners of lots 10 and 11; running thence 80 feet with the rear line of lot 10 as shown on plat to an iron pin at joint rear corners of lots 9 and 10; running thence 180 feet with the side line of lot 9 to the iron pin on Valencia Drive at joint front corners of lots 9 and 10, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes, only.

THIS conveyance is subject to all easements and rights of way of record.
