

PARTIAL RELEASE OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS, that METROPOLITAN LIFE INSURANCE COMPANY, a corporation of the State of New York, for a valuable consideration, the receipt of which is hereby acknowledged, does hereby release and discharge from the operation of a certain mortgage executed by ARTHUR MILLER, JR. to C. DOUGLAS WILSON & CO. a South Carolina corporation, dated September 28, 1962, and recorded September 28, 1962, in the Office of the R. M. C. for Greenville County, South Carolina, in Real Estate Mortgage Book 902, Page 321, and thereafter assigned to Metropolitan Life Insurance Company by endorsement assignment dated September 28, 1962, and recorded in the aforesaid records, such part of the property described therein as is known and described as follows, to wit:

In the County of Greenville, State of South Carolina, near Greenville, S. C., known as portions of Lots 148 and 149 on plat of Orchard Acres, Section 2 in plat book QQ at page 6, and being shown on plat of Arthur Miller, Jr. in plat book XX at page 75, the following metes and bounds, to-wit:

A portion of Lot 148, being a small triangular piece of land described as beginning at an iron pin the joint front corner of Lots 147 and 148 on the northern side of Northway Drive, running thence N 3-11 E, 30 feet to an iron pin, thence southeast 30 feet to an iron pin on the northern side of Northway Drive, thence southwest 4 feet to the point or place of beginning.
