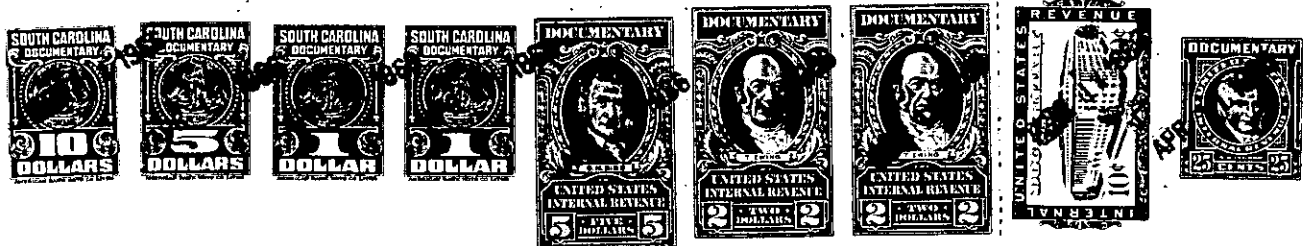
Know All Men by These Presents:

THE CITY OF GREENVILLE, SOUTH CAROLINA; ITS SUCCESSORS AND ASSIGNS FOREVER:

ALL those certain water lines, together with the rights of way, easements, and other interests pertaining thereto, lying and being within the bounds of Pinnacle Drive, Rainer Street (Green Forest Drive), Everest Street, and Edwards Road, in the County of Greenville, State of South Carolina. The water lines and appurtenances conveyed herein consist of 2070' of 6" C. I. Pipe, 2535' of 2" Galv. Pipe, 5 - 2" valves, 3 - 6" Valves, 2 - Fire Hydrants, 1 - 6" Tapping Sleeve and 1 - 6" Tapping Valve, all as shown on plat entitled "Harold Gillespie to City of Greenville", attached hereto and made a part of this conveyance.

TOGETHER WITH all pipes, valves and other mechanical parts and equipment appurtenant to said main and lines and all rights of way and easements necessary or incident to the operation, maintenance, repair or replacement of said water main, pipe lines and appurtenant equipment.



TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors Heirs and Assigns forever.
