in consideration of **Seven thousand nine hundred fifty and no/100 - - - -** Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Leon Moody, his heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 6 of the Perry Property, plat of which is recorded in plat book 1 at page 150, and according to said plat having the following metes and bounds, to-wit:

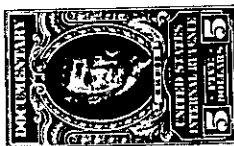
BEGINNING at an iron pin on the north side of Ethelridge Drive at the corner of Lot No. 5, said point being 179.3 feet from the intersection of Ethelridge Drive and Franklin Road and running thence N. 9-26 W., 176.8 feet; thence N. 80 E., 60 feet; thence S. 9-25 E., 174.6 feet to an iron pin on Ethelridge Drive; thence with Ethelridge Drive (leaving a five foot strip for a sidewalk), S. 77-55 W., 60 feet to the point of beginning.
